**WHEREAS**, in consideration for participation at events held or sponsored by the, the **EAST END REGULATORS, INC.**, (hereinafter referred to as "EER") or the observation of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Undersigned agrees to the following:

The Undersigned agrees to indemnify, hold harmless and defend "EER" and any employees, directors, officers or agents and/or instructors from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with: the discharge of firearms; the shooting match to which this release applies and future matches attended by the Undersigned; the Undersigned's participation in the foregoing; the range, buildings, land and premises used for the shooting match (hereinafter referred to as the "Premises"); the Undersigned's presence on or use of said Premises; and any and all acts or omissions of the Undersigned. Should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States or of any State, or under any theory of law or equity, the Undersigned will indemnify, hold harmless and defend "EER" from any and all costs, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against "EER", whether individually, jointly, or severally with the Undersigned, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees.

The Undersigned furthermore waives for himself/herself and his/her executors, administrators, and assignees and heirs-at-law, any and all rights and claims for damages, losses, demands and any other actions whatsoever, which he/she may have or which may arise against "EER", (including, but not limited to any and all injuries, damages or illnesses suffered by the Undersigned or the Undersigned's property), which may, in any way whatsoever, arise out of, be related to or be connected with: the shooting match; the Premises, including any latent defect in the Premises; the Undersigned's presence on or use of said Premises; the Undersigned's property (whether or not entrusted to "EER"); and the discharge of firearms. "EER" shall not be liable for any claims, and the Undersigned, on behalf of himself/herself and his/her executors, administrators, assignees and heirs-at-law, hereby expressly releases "EER" from any and all such claims.

The Undersigned hereby expressly assumes the full risk of entering the Premises and of taking part in any activities on the Premises, which include, but are not limited to, participation or observation of the shooting match, the discharge of firearms and the firing of live ammunition.

The Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all "EER" range rules, instructions and/or procedures and furthermore that he/she is/are solely responsible to have knowledge of and be in compliance of all local, state and federal laws pertaining to firearms.

This instrument is a legal document and binds the Undersigned and his/her executors, administrators, assignees and heirs-at-law.
